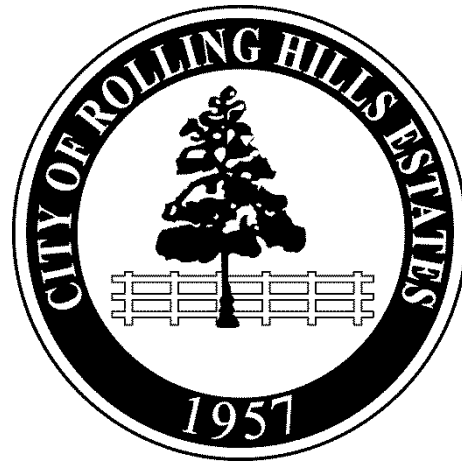

APPENDIX

Landmark Permit CLASSES:

Class 1

- Alterations to exterior of a structure, including signs.
- Additions to an existing building not exceeding 500 square feet in floor area.
- Construction of a new structure not exceeding 500 square feet in floor area.
- Alterations to existing vehicle parking and/or landscaping area.

Class 2

- Additions to an existing structure exceeding 500 square feet and/or development of a new building providing that such construction does not exceed 1,000 square feet of total floor area.

Class 3

- Additions to an existing building and/or construction of a new building exceeding 1,000 square feet of floor area.

Class 4

- Construction of multiple structures and/or additions.

Precise Plan of Design (PPD) CLASSES:

Class 1

- Alterations to exterior of structures.
- Additions to existing buildings in commercial districts not exceeding 400 sq. ft. floor area.
- Construction of new structure not exceeding 400 sq. ft. floor area.
- Alterations to existing vehicle parking and/or landscaping area.

Class 2

- Additions to existing structure exceeding 400 sq. ft. and/or development of new building in an existing developed commercial center providing that such additions do not exceed 2,000 sq. ft. of total floor area.

Class 3

- Additions to existing and/or new buildings to be developed commercial centers exceeding 2,000 sq. ft. of floor space, but less than 10,000 sq. ft. of floor area.
- Development of a previously undeveloped commercial site not exceeding 10,000 sq. ft. of floor area.

Class 4

- All commercial development exceeding 10,000 sq. ft. of floor area and not exceeding 50,000 sq. ft.

Class 5

- All commercial development exceeding 50,000 sq. ft. of floor area.

Horse Trainers, (Page 4)

Any horse trainer conducting business in the City of RHE is required to obtain a business license at the cost of \$300 as well as the following permits:

Category 1: Horse trainers that operate at a private facility and do not use the City's public horse arenas or the City's public trail system or parks. Business License Tax of \$300 per year. Total Cost = \$300.

Category 2: Horse trainers that use only the City's public horse arenas no more than once per week. Business License Tax of \$300.00, a Permit Fee of \$150.00, and a City property use charge of \$100 (not applicable to PWEC use only). Total Cost = \$550.

Category 3: Horse trainers or trail riding operators whose business significantly relies on use of the City's public arenas and/or the City's public trail system or parks. Business License Tax of \$300.00, a Permit Fee of \$250.00, and a City property use charge of \$300. Total Cost = \$850.

APPENDIX (Continued)

The following items provide additional information related to Fees and Charges:

The City charges various fees on a **cost recovery basis** only.

Park Land Dedication Fee: Refer to Municipal Code Sections 16.08

Business Licenses: Refer to Municipal Code Title 5 – Business Licenses and Regulations.

Franchise fees: The City has exclusive franchise agreements based on a fixed percentage of gross receipts with the following companies included but not limited to.

Fees for Southern California Edison, Southern California Gas, and California Water Service Company are all based on 2% of gross receipts arising from the use, operation or possession of the franchise and no less than 1% of the gross receipts derived from the sale of electricity, gas, and water, respectively; Solid Waste Hauler’s franchise fees for residential solid waste are based on percent of gross receipts per agreement.

City of Rolling Hills Estates Municipal Code Section 3.04.060 Fees.

From and after the effective date of the ordinance codified in this section, unless otherwise specified by state law, and excluding those fees established for contract services provided by the county of Los Angeles and others, all permit fees, city service charges and other fees, charges, extractions, and required payments for municipal services, inspections, enforcement activities or for any other purpose, may be established, amended, fixed or modified by resolution of the city council, in addition to any other method prescribed by the Rolling Hills Estates Municipal Code or other law or regulation pertaining thereto. When so prescribed by resolution, the amount thus established shall prevail over any inconsistent provision of the municipal code. (Ord. 519 § 1, 1990).
