Mr. Blodgett stated that he was here before the Planning Commission to get direction so that he can forward the draft housing element to the State Department of Housing and Community Development (HCD). He gave a brief overview of the process, and presented overhead charts outlining the statistics that will be supplied to the HCD.

In response to questions from several Commissioners, Mr. Blodgett stated that a maid living in a room in the home was not considered a residential low-income unit.

In response to an inquiry from COMMISSIONER ZERUNYAN, Mr. Blodgett said that the City may be able to provide certain incentives to those seeking to add second units to their property.

There was discussion regarding the challenge for Rolling Hills Estates to provide second dwelling units and maintain the rural character (lot coverage, etc.).
