He asked the Community Services Director to go with him to Chicago for Ribs to give them an opportunity to give a proposal and price. It was mentioned that perhaps Pavilions could be contacted to see if they would like to be considered to provide food for the City Celebration as they have in the past. It was mentioned that if Chicago for Ribs was again going to provide the food, that they be informed the barbecued beans should be in a separate cup rather than spooned onto the plate.
