### **PEPPER WOOD PARK VISITATION**

The COMMISSION noted the Eagle Scout and Maintenance Department joint effort installing and painting the new three-rail fence to separate Pepper Wood Park and the grass area of the City Hall.

### **SILVER SPUR PARK VISITATION**

The COMMISSION visited Silver Spur Park. The consensus of the COMMISSION was that this park is in very good shape. The following was observed, and the Community Services Director will follow up with these recommendations:

1. Replenish the supply of Bowser Bags.
2. Lower the dedicated plaque to be flush with the grass.

### **ROCKBLUFF PARK**

The COMMISSION visited Rockbluff Park. This park was in very good condition. The play equipment area was heavily used, and the play equipment was in good condition. The following was observed, and the Community Services Director will follow up with these recommendations:

1. Rockbluff Park sign needs to be refurbished.
2. The three-rail fence near the play equipment needs to be repainted.
3. The sprinklers need to be repaired at the northwest corner of the park.
4. Continue to monitor the tot lot where the land continues to settle and sink, allowing the sand to spill out onto the grass area.
