608 SILVER SPUR ROAD LANDSCAPING PLAN

The Community Services Director reviewed the staff report per written agenda material. He indicated that the scope of work that the COMMISSION would be making a determination only pertained to the parkway and sidewalk adjacent to Silver Spur Road. All of the other proposed landscape changes on the attached plan were on private property. The Community Services Director also stated that staff's review of the proposed landscaping changes found that the proposed plants were draught tolerant and complimented the "purple corridor" commercial district landscape plan established in 2000.

Robin Benezra, Landscape Architect for the project discussed the need for sidewalk improvements near the corner of Drybank Drive and Silver Spur Road, in addition to potentially needing to remove or saw cut approximately 210 feet of sidewalk adjacent to the building in order to install irrigation lines to water proposed vine planters. COMMISSIONER PERSICHINA responded that two issues were being presented, but that the COMMISSION only had the authority to approve the landscape plan and not to enable City funding to replace the sidewalk.

planters. The Community Services Director concurred with COMMISSIONER PERSICHINA, that the proposed Creeping Fig vines are highly draught tolerant and once established usually require no irrigation. The Landscape Architect agreed to install the vines without irrigation, eliminating the need to saw cut a long trench in the sidewalk or bore under it laterally.

COMMISSIONER PAGLIANO moved, seconded by COMMISSIONER ALLAN

TO ACCEPT THE 608 SILVER SPUR ROAD BUILDING LANDSCAPE DESIGN AS PROPOSED AND TO ALLOW TEN (10) VINE POCKET PLANTERS OF 8" X 12" TO BE SAW CUT INTO THE SIDEWALK OVER AN APPROXIMATE 210-FOOT LENGTH ADJACENT TO THE BUILDING'S WALL.
