### PORTABLE RESTROOMS

The Community Services Director reviewed the staff report per written agenda material. Discussion ensued regarding the location of the portable restroom at Dapplegray Park. It was noted that it would be located on the PVDE side of the park, and if any complaints were received, landscaping could be quickly added to screen the portable restroom for the trial period. It was stated that the restroom would not be too visible at the location proposed. A-1 Coast Rentals was the low bidder to provide the portable restroom, green in color, and will provide once a week service.

Discussion ensued regarding the Silver Spur Little League's portable restroom installation. It was stated no complaints have been received regarding aesthetics, vandalism or inappropriate uses during the trial summer period.

# **DIRECTOR'S ITEMS**

The Community Services Director reviewed the press coverage received on the Nature Center's night hike.

## **COMMISSION ITEMS**

Adopt-A-Park Reports— CHAIRWOMAN VULLO reported on her review of Howlett Park. She questioned whether the area behind the tennis area could be used for a mini skateboard park or be used for some other purpose. It was noted that the area is relatively small to conduct any type of recreation sport. CHAIRWOMAN VULLO stated one of the Tennis Club employees had requested another window be installed in front of the desk in the office, as some tennis players are trying to walk by the office without paying fees, and the additional window will provide a better view of tennis club patrons entering the area.

CHAIRWOMAN VULLO stated the area around the bleachers at the tennis courts needs to be cleaned on an ongoing basis.

COMMISSIONER PIERSON reported that the Stables is in need of maintenance, but is reluctant to suggest any improvements due to the impending stables relocation.

COMMISSIONER PERSICHINA did not report any potential concerns at Dapplegray Park.

COMMISSIONER VANDEN BOS reported that the grass is coming in nicely at Highridge Park. He reported that where the goals are located, the grass is slow and will need some maintenance. Rocks have been coming up in the fields, particularly in the west field where big rocks are exposed in the center of the field.

COMMISSIONER VANDEN BOS stated that at Silver Spur Park, he would suggest an opening be made in the fence along Silver Spur Road up at the top of the park.

COMMISSIONER CLEWIS did not report any potential concerns at the Nature Center. The Community Services Director reported that the City is one of 9 finalists for a grant. A decision will be made within the next two months.

<u>Mayor's Breakfast Ride – May 4, 2002</u>–COMMISSIONER PIERSON stated there were 27 riders in this year's Breakfast Ride, and the pancake breakfast was again popular.

<u>City Celebration Subcommittee Update</u>— The Community Services Director stated the City Celebration is progressing on schedule and the next subcommittee meeting is scheduled for Tuesday, July 16 at 6:00 p.m. (Ernie Howlett Park).

<u>Holiday Party (December 5, 2002)</u>— The event will be held at the Rolling Hills Country Club. Members of the subcommittee: Vullo, Pekich, Vanden Bos.
