DECEMBER 14, 2009

1. CALL MEETING TO ORDER

8. PUBLIC HEARINGS

A. PLANNING APPLICATION NO. 35-09; APPLICANT: PENINSULA ACADEMY; LOCATION: 550 DEEP VALLEY DRIVE #277; A CONDITIONAL USE PERMIT

FOR A PROPOSED LEARNING/TUTORIAL CENTER IN THE COMMERCIAL GENERAL ZONE.

Principal Planner Cutler gave a brief Staff Report, as per written material, and recommend adoption, including special conditions.

CHAIRWOMAN BAYER asked about the number of non-instructional staff and suggested that the resolution accommodate them.

CHAIRWOMAN BAYER then asked about the impact of taking retail space for a service-related business. Planning Director Wahba responded that typically the 3rd floor has been more conducive to the service industry and has struggled with respect to retail. Planning Director Wahba further suggested that City Council revisit the CUP for the mall regarding how tenanting should react to market demand for non-retail space (service, mixed-use, etc.) to bring foot traffic into the mall. At this point, however, this project complies with Code and has plenty of parking available.

Liz Griggs (General Manager of the Promenade on the Peninsula) came forward and relayed to the Commission how thrilled she is that the applicants have moved their business to the mall. Ms. Griggs commented on the economic challenges and the mall's commitment to keeping the property viable by aggressively marketing the center.

Ms. Griggs and the Commission then discussed lease terms and possible future tenant mixes
