REGULAR PLANNING COMMISSION MEETING

MARCH 4, 2002

A regular meeting of the Planning Commission of the City of Rolling Hills Estates was called to order at 7:30 p.m. in the City Hall Council Chambers, 4045 Palos Verdes Drive North, by CHAIRMAN ZERUNYAN.

7. BUSINESS ITEMS

A. PLANNING APPLICATION NO.05-02. A PRECISE PLAN OF DESIGN FOR EXTERIOR FAÇADE IMPROVEMENTS AND BUSINESS IDENTIFICATION SIGN. APPLICANT: PAVILIONS (VON'S MARKET) LOCATION: 7 PENINSULA CENTER

Senior Planner Wahba gave a staff report (as per written material) and gave the Commission a color and material board to pass around.

Staff recommends the Planning Commission approve Planning Application No 05-02.

In response to COMMISSIONER CONWAY, Senior Planner Wahba stated that the path of travel is striped on the pavement. The location of the trash enclosure is behind the buildings, near the loading dock. The trash receptacles are shared with other businesses.

In response to COMMISSIONER CONWAY, Director Orci confirmed the City's requirement to enclose the trash containers.

There was much discussion with COMMISSIONER CONWAY regarding the trash receptacles, their enclosure and working with the management of the center for the common area.

In response to COMMISSIONER REIN, Senior Planner Wahba stated that the columns would not hinder visibility, pedestrian safety, and vehicle access, and that this issue was studied previously. The issue was studied by the City Engineer Willdan & Associates.

Director Orci stated that the previous applications expanded the width of the sidewalk.

In response to COMMISSIONER REIN, Senior Planner Wahba responded that access for the pedestrians would improve due to eliminating the entrance/exit in the center of the façade. The columns are structural and can be further discussed by the applicant.

In response to COMMISSIONER VULLO, Senior Planner Wahba stated that the "Mayers Bakery" will have a wall sign. He added that it was not within the arches and that the color palette is the same as other businesses.

Director Orci commented all the tenants are required to get new signs as part of the Planning Commission's condition of approval.

Mr. Al Ziemba, architect for Von's Pavilion, said that they had imitated the palette created for the remainder of the center and incorporated various elements into the design. They will have ADA compatibility and a barrier-free path of travel from the parking lot. An interior remodel was also proposed with new décor and new departments. He provided the Commission with a booklet showing comparisons of the new and old building design.

In response to COMMISSIONER CONWAY, Senior Planner Wahba indicated that the requirement to enclose or relocate the trash receptacles could be a condition of approval. Due to the sharing of the trash containers in the area this would need to be determined by the landlord.

COMMISSIONER CONWAY moved, seconded by COMMISSIONER BAYER

TO APPROVE PA-05-02 WITH THE CONDITION THAT THE APPLICANT RELOCATE AND/OR ENCLOSE THE TRASH ENCLOSURES TO THE SATISFACTION OF THE PLANNING DIRECTOR.
