### 7. BUSINESS ITEMS

A. PLANNING APPLICATION NO 38-02; APPLICANT: MR. SAM MAUS LOCATION: 3717 PALOS VERDES DRIVE NORTH. A REQUEST TO APPROVE A NEIGHBORHOOD COMPATIBILITY DETERMINATION FOR FIRST AND SECOND STORY ADDITIONS LOCATED ON THE FRONT, SIDES, AND REAR OF AN EXISTING TWO-STORY HOME, AND A HILLSIDE GAZEBO.

#### 8. PUBLIC HEARINGS

A. PLANNING APPLICATION NO. 24-02 APPLICANT: MS. MADELINE DEL SIGNORE LOCATION: 15 SORREL LANE. A REQUEST TO APPROVE A NEIGHBORHOOD COMPATIBILITY DETERMINATION FOR FIRST AND SECOND STORY ADDITIONS AT THE FRONT, SIDE AND REAR YARDS OF A TWO-STORY HOME. A MINOR DEVIATION, GRADING PERMIT, AND FOUR VARIANCE APPLICATIONS ARE ALSO REQUESTED.

Assistant Planner Tran gave a staff report (as per written material) and recommended the Planning Commission Open the public hearing; Take public testimony; Discuss the issues; Close the Public Hearing; and, direct staff to prepare a resolution approving PA-24-02 with the Plan B alternative.

Assistant Planner Tran responded to COMMISSIONER KILLEN'S request to discuss Plan A and Plan B alternatives.

Director Wahba responded to COMMISSIONER CONWAY and COMMISSIONER KILLEN'S questions regarding Gable and hip roof designs and the "Ranch Style" and the roof compatibility with the neighborhood.

COMMISSIONER CONWAY asked about the property loss of 5 feet. Director Wahba stated that it was a property line change and not an easement.

Mr. Frank Politeo, architect for the applicant, stated that he hoped to have the application approved and did prefer Plan B. He stated that he and the applicant had worked extensively with staff and hoped the final plan would be compatible with the neighborhood.

Ms. Del Signore, the applicant, addressed COMMISSIONER CONWAY'S question regarding the 5-foot property line adjustment issue and the circumstances that brought about that change. She further indicated that she and the architect, had worked with staff to eliminate as many variances as possible.

COMMISSIONER BAYER stated that she was glad this project is complete and that the home retained a lot of its original structure, appeal, and character.

Ms. Del Signore responded to COMMISSIONER CONWAY'S question regarding the chimney and she indicated she preferred to have a wood burning fireplace rather than a gas fireplace for personal reasons.

COMMISSIONER BAYER moved, seconded by COMMISSIONER SOMERS

COMMISSIONER SOMERS complimented the Planning staff on the report, their analysis, the presentation of pros and cons, and how well supported the documentation was

COMMISSIONER KILLEN expressed his concern about the prior planning application approval and how they only wanted one variance, and the concessions they were required to make, and this application is going to have approval of four variances.

COMMISSIONER CONWAY also asked about the 50% Rule. Director Wahba discussed the current interpretation of the 50% Rule. He stated that in future situations staff would recommend and consider only the structure(s) that are being altered and not detached structures as part of the linear wall calculation and added square footage calculations.
