7. <u>BUSINESS ITEMS</u>

A. PLANNING APPLICATION NO. 03-03; APPLICANT: DAVID BRUNNENMEYER; LOCATION: 11 ENCANTO DRIVE; A NEIGHBORHOOD COMPATIBILITY FOR FIRST AND SECOND STORY ADDITIONS LOCATED AT THE FRONT, SIDE, AND REAR YARDS OF A SINGLE STORY HOME; AND MINOR DEVIATIONS TO DECREASE THE FRONT YARD AREA BY LESS THAN 10% AND TO ENCROACH INTO THE WEST AND EAST SIDE YARD SETBACKS BY LESS THAN 10%.

Assistant Planner Tran summarized the Staff Report (as per written material) and revised the staff recommendation to approve the side yard setback Minor Deviation.

In response to a questions from COMMISSIONERS BAYER and CONWAY, COMMISSIONER KILLEN explained concerns regarding the roof structure and stated that it was unbuildable, as designed.

Director Wahba suggested that the area in question to the rear of the house with the roof design issue could be solved with a tower element.

David Brunnenmeyer, applicant, explained to the Commissioners that there were a few options for design of the roof. He stated that of those options he choose the hardest design to build, but he felt it was the best looking.

TO APPROVE PA-3-03 (APPROVING ALL THREE MINOR DEVIATIONS) WITH THE STANDARD CONDITIONS OUTLINED IN THE STAFF REPORT, AND THAT THE APPLICANT WORK WITH THE PLANNING DIRECTOR TO REDESIGN THE ROOF ELEMENT LOCATED AT THE REAR OF THE HOUSE.
