REGULAR PLANNING COMMISSION MEETING

MAY 3, 2004

A regular meeting of the Planning Commission of the City of Rolling Hills Estates was called to order at 7:30 p.m. in the City Hall Council Chambers, 4045 Palos Verdes Drive North, by CHAIRMAN KILLEN.

2. PLEDGE OF ALLEGIANCE

4. <u>APPROVAL OF MINUTES</u>

COMMISSIONER CONWAY moved, seconded by COMMISSIONER BAYER

TO APPROVE THE MINUTES OF THE REGULAR PLANNING COMMISSION MEETING OF APRIL 19, 2004.

There being no objection, CHAIRMAN KILLEN so ordered.

6. <u>CONSENT CALENDAR</u>

COMMISSIONER SOMERS requested a vote of Item 6 A and it was moved to Business Items.

B. A RESOLUTION (PA-01-04) FOR APPROVAL OF A NEIGHBORHOOD COMPATIBILITY FOR CONSTRUCTION OF SINGLE STORY ADDITIONS TO THE SIDES AND REAR YARDS AND A VARIANCE TO EXCEED TO MAXIMUM FRONT YARD LOT COVERAGE, APPLICANT: MS. AMY FORTUNE; LOCATION: 12 ENCANTO DRIVE.

COMMISSIONER CONWAY moved, seconded by COMMISSIONER BAYER

TO APPROVE RESOLUTION PA-01-04.

Director Wahba clarified the "Waiving of Readings" to CHAIRMAN KILLEN.

COMMISSIONER SOMERS asked for discussion from the COMMISSIONERS regarding Consent Item B.

COMMISSIONER SOMERS stated that he felt that Staff was correct in opposing Resolution PA-01-04.

CHAIRMAN KILLEN commented that he was sympathetic to the location and neighborhood and their neighbor next door, and they had a tough site to work with.

COMMISSIONER VANDEN BOS stated that he felt this was a special case also and did not know what else the homeowner could do.

COMMISSIONER CONWAY stated that the property is a flag lot, and the view from a public rights of way supported the approval of the application.

COMMISSIONER BAYER stated that she concurred with the Commissioners comments and the extensive work the applicant had done to work with staff.

COMMISSIONER O'DAY commented that the courtyard style that it does give an illusion from the exterior that the building mass is covering the entire lot and the open space is concealed.

B. PLANNING APPLICATION 11-04; APPLICANT: PENINSULA CENTER (SPECTRUM HEALTH CLUBS) LOCATION: 51-D PENINSULA CENTER.

Assistant Planner Wong summarized the staff report (as per written material) and stated that staff recommends the Planning Commission approve PA-11-04.

COMMISSIONER BAYER moved, seconded by COMMISSIONERS CONWAY

TO APPROVE PA 11-04.

8. PUBLIC HEARINGS

A. PLANNING APPLICATION NO. 07-04; APPLICANT: MR. DAVID FARRELL; LOCATION: 10 HIDDEN VALLEY ROAD. THE APPLICANT IS REQUESTING APPROVAL OF A NEIGHBORHOOD COMPATIBILITY TO ALLOW AN AFTER THE FACT ACCESSORY STRUCTURE BUILT IN THE EAST SIDE YARD. A. VARIANCE IS REQUIRED FOR A DECREASE IN THE 10' SIDE YARD SETBACK FOR THE STRUCTURE.

Planner Wong summarized the staff report (as per written material) and recommended that the Planning Commission Open the Public Hearing; Take public testimony; Close the Public Hearing; Discuss the issues; and Continue the application to a date uncertain to allow the applicant, attorneys, and staff to work further on redesigning the project.

CLOSE THE PUBLIC HEARING FOR PLANNING APPLICATION 07-04.

CHAIRMAN KILLEN so ordered.

Director Wahba discussed the concern that he and the City Attorney, Richard Terzian had, that a precedence could be set on encroachment in the required setbacks.

The COMMISSIONERS discussed previous similar situations and potential variance findings.

COMMISSIONER BAYER moved, seconded by COMMISSIONER CONWAY

TO CONTINUE THE PUBLIC HEARING FOR PLANNING APPLICATION 07-04 TO A DATE UNCERTAIN.
